Annual Dues

<p>Regular IFBOA Membership: Applies to members who desire to participate in the IFBOA General Aviation Workers Compensation Insurance Program and other discounted purchasing programs. In addition, these members will receive <i>NATA News</i> each week, providing information on policy and advocacy matters that affect aviation businesses. If already a member of the National Air Transportation Association (NATA) this membership is reduced to \$150 per year.</p>	
<p>IFBOA+ Membership: Members receive access to all benefit programs offered by both IFBOA and NATA, including industry-leading Safety 1st Training, advocacy for aviation businesses, networking events, and more. The membership calculation is based upon the number of Full Time Equivalents (FTEs). For corporate flight departments, the applicable FTEs are only those employees in the flight department. If electing this expanded category of membership, companies or departments may join NATA for an additional \$150 annual fee.</p>

FlexPay

IFBOA heard your request and delivered. To make the renewal process as simple as possible, IFBOA now offers monthly payments for your Annual Dues: FlexPay*. FlexPay is only available for credit cards.

If you select this option, IFBOA will process your payment on the first of each month, as follows:

GER Deduction

****NOTE**** This payment method only applies to Regular IFBOA Memberships with dues of \$400 per year; \$150 if already a member of the National Air Transportation Association (NATA).

As a convenience to you, IFBOA is providing an alternative method to pay your 2017 membership dues. In order to keep expenses low and maintain dues at the 2016 rate, this option allows members to deduct their annual dues from expected Good Experience Returns (GER) at the end of the year.

Members can participate in this payment method by completing this option on the invoice and sending it to IFBOA. The Program Administrator will be instructed to deduct the appropriate membership dues at year's end.

Only members in good standing have the right to participate in the IFBOA Workers Compensation Insurance Program, which last December provided a GER exceeding 20%. Don't miss this opportunity—renew today and continue receiving your GER.
